TUITION: Individual 50 minute sessions cost \$85 per session, paid at time of session.

Rates for prepaid sessions are as follows:

3 sessions prepaid \$255 (\$85 per session)

6 sessions prepaid \$510 (\$85 per session)

12 sessions prepaid \$960 (\$80 per session)

Payment plan proposals are welcome and can be customized with written agreement in a case by case manner. *A sliding fee scale is available by request for income eligible clients.*

CONSULTATION:

We offer three levels of consultation:

1-Consultation only: (Free) 30 minutes

2- Consultation, plus Records Review (Cost \$50)

3- Consultation, Records Review, Comprehensive Assessment (3 Diagnostic Sessions) and Report/Follow up Consultation (\$325)

We do require a \$50 deposit, or payment in full, at this time to hold the space for the student for the Comprehensive Assessment.
